David Thornburgh, President and CEO of the Committee of Seventy Time for Truth about Pennsylvania's 2020 Presidential Election

Interview Summary

Pennsylvania's historic election-reform law, which took effect on October 31, 2019, authorized no-excuse, mail-in voting and passed both houses of the legislature with strong bipartisan support. After the presidential election in 2020, then-President Trump and his allies, including some elected officials from Pennsylvania, unsuccessfully sought to overturn the results of our election in every available forum, including the courts and the Congressional session that was interrupted for several hours by the January 6 riot in the Capitol. David Thornburgh is the President and CEO of The Committee of Seventy, a non-partisan organization that was founded in Philadelphia in 1904 and is one of the country's oldest good government groups. Its mission emphasizes strengthening democracy and protecting and improving the voting process in Pennsylvania. Mr. Thornburgh is considered by many to be Pennsylvania's leading expert on elections. He will discuss the issues surrounding an election that has been relentlessly attacked as fraudulent by some but that most have concluded was free and fair.

Suggested Written Reflection Questions

- □ David Thornburgh refers to the Pennsylvania presidential election as the "ubiquitous perfect storm." What do you think he means by this? How could these political and election administration issues have been defused before the election?
- □ Election officials could not start counting mail in ballots until 7:00 am on election day. In hindsight, if you were an election official in Pennsylvania, how would you have prepared for election day? If you were a legislator, how would you reform Pennsylvania's election laws to better prepare for future elections?
- ☐ What did you find interesting in the interview? What is something that you disagreed with?

Suggested Classroom Discussion Questions

- □ David Thornburgh gave Pennsylvania a B+ for its performance and an A for effort in the presidential election. Why did he give it a B+? What grade would you give Pennsylvania?
- ☐ The Pennsylvania Supreme Court barred Congressman Mike Kelly and others' challenge to Act 77 by the doctrine of laches. The Court has been criticized for not answering whether Act 77 is constitutional. Do you think the Court should have spoken to the constitutionality of Act 77?
- ☐ Moving forward, what issues does Pennsylvania still need to address to better prepare for future elections?
